

## **BOMA EXPERIENCE EXCHANGE REPORT PROGRAM USER LICENSE AGREEMENT**

The Experience Exchange Report of the Building Owners and Managers Association International (“BOMA”) compiles data and information from a wide range of industry sources to produce comprehensive benchmarking information for the management of commercial buildings. BOMA is a nonprofit corporation incorporated in the State of Illinois, with headquarters in Washington, DC, and which is also tax exempt under Section 501(c)(6) of the Internal Revenue Code.

Please carefully read the following terms and conditions before using BOMA’s Experience Exchange Report, and **click “I accept” to indicate your acceptance of these terms and conditions**. Any use of the Experience Exchange Report also indicates your acceptance of these terms and conditions.

### **Section I: License Agreement**

BOMA hereby grants to you (“Licensee”) a non-transferable, non-exclusive license to use a certain computer software program, including all screen displays and search results generated from the computer software program, known as the Experience Exchange Report (the “Program”) solely in accordance with the terms and conditions of this Agreement. Licensee hereby agrees to use the Program subject to the following terms and conditions and understands that BOMA has the right to terminate this Agreement if Licensee violates any of its provisions. The scope of use permitted under this license is contingent upon timely payment of the applicable fees. This license and authorization for use shall be null and void if the fees are not paid and BOMA reserves the right to take all legal action to prevent any unauthorized use. The license granted under this Agreement authorizes only the Licensee to use the Program as a single user. **Licensee shall not copy or print any information from the Program except for use solely in internal reports and analyses. Information from the Program shall not be used for external purposes or any sale, resale, distribution, or any other commercial use without the express written permission in advance from BOMA. Licensee shall make best efforts to protect the Program against unauthorized use or reproduction.** BOMA and Licensee agree that this License Agreement will govern Licensee’s use of the services and software described herein, and such License Agreement will not be modified in any material way without the parties’ mutual agreement.

### **Section II: Confidentiality**

The preparation of the Program is undertaken on a confidential basis in accordance with BOMA’s nonprofit and tax exempt status and all applicable laws, including the antitrust laws. BOMA has taken extreme care and exercised high standards of statistical procedures in obtaining, processing, and reporting data in the Program and offers it as a useful service to the office building industry and the public. All data in the Program, not just the income and expense information but the names of the buildings that are included in each city, are kept confidential. This obligation extends not just to BOMA, but to all Program users, including BOMA’s local association members and executives. The data reported in the Program is necessarily limited to information received from survey responses and should not be viewed as representative of the entire industry.

### **Section III: Limitation of Liability**

BOMA SHALL HAVE NO LIABILITY TO LICENSEE OR ANY OTHER INDIVIDUAL OR ENTITY CONNECTED WITH THE LICENSEE FOR ANY CLAIM, LOSS, OR DAMAGE OF ANY KIND OR NATURE WHATSOEVER ARISING OUT OF OR IN CONNECTION WITH THE PROGRAM, WHETHER OR NOT KNOWN OR DISCLOSED TO LICENSEE.

Section IV: No Warranty

BOMA IS PROVIDING THE PROGRAM FOR LICENSEE'S EDUCATIONAL AND RESEARCH USE ONLY. THE PROGRAM IS PROVIDED "AS IS" AND LICENSEE ACCEPTS THE ENTIRE RISK AS TO THE QUALITY, PERFORMANCE AND RESULTS OF USE OF THE PROGRAM. BOMA MAKES NO WARRANTIES OR REPRESENTATIONS, EXPRESS OR IMPLIED, ORAL OR IN WRITING, WITH RESPECT TO THE PROGRAM, INCLUDING ITS FITNESS FOR A PARTICULAR PURPOSE, MERCHANTABILITY, QUALITY OR ITS NON-INFRINGEMENT.

Section V: Indemnification

Licensee will be solely responsible for the operation and permitted use of the Program. Licensee specifically undertakes to indemnify and hold BOMA harmless from any loss or damage (or claim thereof) resulting from operation or use of the Program and related output; provided such loss or damage was not caused solely by BOMA's negligent or willful act.

Section VI: Proprietary Property

The names and marks BUILDING OWNERS AND MANAGERS ASSOCIATION INTERNATIONAL, BOMA, EXPERIENCE EXCHANGE REPORT, and EER are the proprietary intellectual property of BOMA and may not be used in any manner without prior written authorization from BOMA.

The Program is the sole and exclusive property of BOMA. Reproduction or redistribution of the Program in whole or in part without the express written consent of BOMA is prohibited.

Section VII: Assignment

This Agreement and the Program may not be transferred, assigned, or sublicensed by Licensee without the prior written consent of BOMA.

Section VIII: Jurisdiction

Licensee hereby agrees that the laws of the District of Columbia will apply to interpretation of this Agreement and further accepts the exclusive jurisdiction of the federal or local courts in the District of Columbia with respect to any claims brought in connection with violation of this Agreement or any use or misuse of the intellectual property of BOMA, including the Program.
